

## **CASE: request for investigation**

**The signatories request the International Criminal Court to examine the following case in order to take the necessary legal actions. In our opinion, the Government of Finland and various other parties operating under its auspices and with the help of it, hereinafter referred to as the parties, have committed exceptionally large-scale and systematic crimes against humanity in the context of measures and decisions taken with covid-19 pandemic in 2020 and 2021. These actions limiting freedoms of citizen have seriously violated human right as stated in Articles 2, 3, 5, 12, 13, 19, 20 and 28 of the Universal Declaration of Human Rights and Articles 3, 5, 8, 9, 10, 11, 13, 14 and 17 of the European Convention on Human Rights as well as Nuremberg code.**

## **Procedures and decisions that the complaint is based on**

The action concerns measures taken by the highest institutions of the Finnish state, including the government of Finland, which have caused and will continue to have unprecedented consequences for public health and the economy, as well as large-scale violations of the fundamental rights of citizens. Finnish government has decided and implemented the prohibitions and regulations listed above, which have severely restricted citizens' fundamental rights, such as freedom of movement, freedom of assembly and the right to conduct a business. These measures have been both ineffective and misdirected in the light of scientific knowledge and completely excessive in relation to the health threat they are intended to address. At the same time several political measures can reasonably be expected to

cause significantly more harm than good to public health. Such ineffective and unhealthy decisions concerns in particular the use of a face masks, which has been made compulsory in many places like transport and work. Highly manipulative propaganda has been used for general recommendation for the use of facemasks. This call for continuous use of the mask has been made contrary to well-established scientific knowledge about the detrimental effects of long-term use of the face mask. Especially concerning is recommendation of facemask for children and youth as it causes disturbances in the brain development of young children. Similarly, the country's top government agencies, together with the authorities listed above, have put extraordinarily strong pressure on the public to take experimental vaccinations against the covid-19 virus. In addition to the intimidation campaign, which is inappropriate and goes against the valid statistical data, the preparation of a the so called vaccination passport project, would result in refusal of a number of domestic services for those persons who won't take a corona vaccination and would cause significant violations of their fundamental rights of free movement. Similarly, a pressure campaign, organized through a large-scale, one-sided and inaccurate propaganda, has almost exclusively promoted a vaccination certificate, thus ignoring alternative evidence of virus resistance, such as antibody tests or other coronavirus infection certificates. The above and several other measures related to the same coronavirus epidemic can reasonably be considered to be planned and intentional in terms of their consequences and objectively arbitrary, unjustified and contrary to known scientific knowledge. Due to the fact that state decision making bodies has had access to the best possible knowledge and scientific information, and as they are subject to the obligation under Chapter 6, Section 31 of the Administrative Procedure Act (6.6.2003 / 434) to investigate the matter thoroughly prior to taking a decision thereof, the signatories consider that the above harmful and illegal criminal activities are of a malicious nature - per se as *dolus determinatus*, but at least as *dolus directus*. Decision-makers must be deemed to have either explicitly sought the adverse consequences described above, or at least to have been fully aware of the harmful and illegal consequences of their decisions.

This request for an inquiry contains *prima facie* evidence of the enormous and partly irreversible damage, referred above, to the mental, physical and economic well-being of the people caused from March 2020 by the claimed "*lawful, effective and necessary*" actions of the people. These illegal activities must be stopped immediately and those who decide on them must be held criminally liable. The evidence is requested to be supplemented on the basis of new material and information gathered during the proceedings.

In Finland, the restrictive measures imposed on the people are mainly based on the incorrect application of the Infectious Diseases Act in force (21.12.2016 / 1227) and the Preparedness Act (29.12.2011 / 1552). The Finnish government has made unfounded recommendations and "guidelines" that are badly exaggerated in terms of the viral epidemic, the practical implementation of which has taken place on the basis of regulations issued by THL and regional authorities. The "Corona Epidemic" does not meet the criteria of the Communicable Diseases Act for general danger, the Emergency Preparedness Act for exceptional circumstances or the requirement for a serious infection required by the Communicable Diseases Decree (9.3.2017 / 146, 69/2020). Established and globally comprehensive statistics show that coronavirus infection can pose a risk of serious illness and death in practice only to the oldest age groups, and that serious illnesses such as diabetes or high blood pressure are almost always present in severely ill individuals. Globally, the proportion of seriously ill people is less than half a percent of all those infected, including the risk groups referred to above. In the case of Finland, it can also be stated with certainty that the viral epidemic has not increased mortality in any part of the population. In this respect, it is clear that corona viral infection cannot meet the criteria of general danger mentioned above.

The signatories request the Criminal Court to investigate the actions taken by the above-mentioned parties in violation of Finnish law and international agreements binding on Finland. In Finland, numerous protests, complaints and criminal reports have been filed on the same subject matter from the above-mentioned bodies to the competent law enforcement authorities, without, however, leading to judgments or even investigations.

In the view of the signatories, there is a need for judicial protection before the International Criminal Court, given the exceptionally large and systematic nature of the action at issue and the collective and complex crimes which required the active involvement of the State. For this reason, they have been and will continue to be unexamined and not convicted by national courts.

## **Brief summary of the evidence on which the request for an investigation is based on**

The request is based on global disease and mortality statistics produced by THL, the National Institute for Health and Welfare, which provide the only scientific premise for disease risk assessment, international studies, and the Facts About Covid-19 database of 1000+ experts (2). (3) A large number of official investigations have been compiled in an extensive database. An up-to-date database was created to provide a realistic picture of the corona situation as a counterweight to what the media provided. In addition, it serves as a body of evidence for criminal prosecutions in national and multinational courts. It has been revealed that corona, which is quite harmless to the majority, has been manipulated into a "pandemic" for economic gain through the systematic falsification of death statistics and the widespread use of inappropriate PCR tests giving false positives.

Criminal cases concerning the corona "pandemic" are pending in Belgium and Canada (see below); a multinational lawsuit is being prepared at the time of writing, at least in Germany. Reiner Fuellmich, PhD, who belongs to the above-mentioned group of experts, has been sentenced to e.g. Deutsche Bank and Volkswagen. In this video (4), Dr. Fuellmich explains the rationale for classifying a corona pandemic as a crime against humanity, and the role that authorities in different countries play in this cross-border organized crime:

"This corona crisis, based on everything we know about it today, must be renamed the corona scandal. And those responsible are punished and sued for harm to citizens. At the political level, everything possible must be done to ensure that no one can be in the same power in the future to deceive humanity or to manipulate us to achieve its corrupt agendas. "

Criminal charges are based on the universal principle of international criminal law on the conviction of conspiracy-type crimes (Customary International Law, Conspiracy / Joint Criminal Enterprise). Similar criminal proceedings may be instituted against the Finnish authorities.

### **1. Unjustified and illegal corona acts – prima facie evidence**

Statistics are central to societal decision-making. Without statistics, it is not possible to assess the need for education and day care places, build hospitals or infrastructure.

Relevant statistics on the number of deaths and the age / health distribution are central to assessing whether there is a need for large-scale public health interventions at all. Scientific evidence / THL statistics do not justify this in a corona situation. Consequently, the need for large-scale restrictive measures, which violate fundamental human rights and cause great damage to the national economy and health - let alone the legal right to do so - has never emerged.

In early March 2020, the WHO reported on the corona that "this virus is not SARS, neither MERS nor influenza," but "a unique virus with unique characteristics." According to the WHO, both Covid-19 and influenza cause respiratory diseases and spread in the same way from droplets and nasal secretions in an infected person, but "there are significant differences in infectivity between COVID-19 and influenza. COVID-19 is not as easily transmitted as influenza. In the case of influenza, people who have been infected but are not yet symptomatic are the largest group of infectious agents, which does not appear to be valid for COVID-19. " (5)

This information, which has since been confirmed in countless studies, has also come from WHO to THL, which advises the Finnish government. There was no real cause for panic at any point.

### **1.1 Closure of Finland**

On March 16, 2020, the government, together with President Sauli Niinistö, stated that Finland was in exceptional circumstances and resorted to the emergency preparedness law on the basis of the coronavirus epidemic. With the introduction of the Emergency Preparedness Act (total destruction below):

- The Uusimaa region was isolated from other counties for several weeks. You only got into the area for a serious reason
- Hospital surgical and other wards were widely closed, with up to 90% of health care resources "freed up" for the needs of pandemic patients. Hundreds of thousands of patients were left without the necessary treatment or diagnosis of cancer and therefore will die prematurely. At no point has the coronavirus epidemic significantly increased the utilization rate of intensive care or other health care capacity.
- Theaters, museums, restaurants were closed, children's sports activities were canceled
- Education at all levels shifted to distance learning. Children and young people were left without physical contact in friendships, which is paramount for mental health. No wonder children's mental health problems have exploded, and suicide rate is increasing.
- The elderly was isolated in homes and nursing homes, many of whom died without seeing their loved ones, resulting in immeasurable human suffering as well as sick elderly people living in the last weeks of life as well as their loved ones. There are no proper grounds for isolation decisions - the protection of at-risk groups should have been entirely voluntary.
- Newborns were isolated from their parents, which is detrimental to the baby's development
- Restrictions on gatherings were imposed, which at the same time led to a ban on virtually all expressions; public events were canceled, companies laid off and laid off their employees after losing their customers. In many cases, the government also directly urged citizens to avoid using services such as accommodation and catering, even though the activities of providers of these services were not explicitly prohibited. This, of course, had a devastating effect on the profitability of those industries. In June 2020, more than 35,000 small entrepreneurs relied on The Social Insurance Institution, Kela's labor

market support. Kela is the government agency that provides basic economic security for everyone living in Finland.

- People were beaten to telecommuting, which made it difficult or impossible for many companies to do business
- Travel restrictions were imposed, which has practically crippled the transport and tourism industry
- Protective plaques and tapes requiring physical distance began to appear in public spaces and shops - nonsense for which only psychiatry provides a scientific explanation
- The state commissioned the Corona Flasher app, which “registers” and warns of the infection of a negligible virus alongside seasonal flu. The application laid the foundation for more effective technical supervision of citizens, although this motive was disputed by decision-makers.
- Prolonged use of face masks, even in the vicinity of young children, is detrimental to children's brain development

Chapter 1 of the Emergency Preparedness Act requires the authorities to take "necessary and proportionate measures ... to halt a particularly serious, dangerous and very widespread communicable disease." According to Article 4 of that chapter:

"In exceptional circumstances, public authorities may be authorized to exercise only such powers as are necessary and proportionate to achieve the purpose provided for in Article 1." None of these conditions of the law were fulfilled for the corona "pandemic." Recourse to the Standby Act and other proposals for restrictive measures are only seemingly legal, and thus in fact unlawful.

The Government's policy of 16 March 2020, which prohibits outsiders' visits to health care facilities, health care units and hospitals, excluding asymptomatic relatives of critically ill and children, relatives of those in care and a spouse or support person in the maternity ward, is justified under section 17 of the it is pointed out that such a restriction may not be possible at all under that provision. (6,7)

## 1.2 Statistical sample

According to the WHO's own definition, corona is a virus that does not infect as easily as influenza and is harmless to the majority - it has also been scientifically proven. Much more deadly viruses have been

controlled throughout human existence with common sense and enhanced hand hygiene - such as the sudden seasonal flu. And this should have been the case for the "corona" as well.

The corona "pandemic" lags far behind seasonal influenza and other common causes of death in EU countries in terms of its immediate health effects (statistical analysis below).

First, seasonal flu, which is occasionally up to 5 times more deadly than corona:

"Influenza is estimated to cause as many as 2,000 deaths in Finland every year. Influenza can occur in as many as one in five. Even in mild influenza periods, there are usually several hundred influenza deaths. Influenza usually causes a total of about 15,000 to 70,000 premature deaths in Europe each year. This is an estimate. The actual number is difficult to know because, due to diagnostic practices, influenza is not noted as a cause of death and not always as a contributing factor. About 12,000 influenza findings were reported in Finland in 2019-20 in the infectious disease register. " (8) Hanna Nohynek of THL reported on the flu for which "there is a vaccine". Still, flu that is more deadly than corona and can occur in every fifth person in Finland - well over a million people!

Then the exceptionally bad seasonal flu: Matti Virtanen wrote about a really bad season of influenza in Tekniikan Maaailma No 11 in 30.3.2020.

"The flu epidemic in Europe is causing more than 200,000 extra deaths compared to the normal flu season. In Finland, too, the disease is rare and kills an estimated 1,400 more people than usual. No, this was not a prediction of the current corona virus, but the exceptional mortality of season 2016-2017 and it is clearly reflected in the overmortality statistics of the Euromomo, which measures mortality. "

The 2016–2017 flu season lasted 27 weeks, up to 5 weeks longer than usual. (9)

And finally, the corona- "pandemic." Direct quote from the correct THL statistics (situation on 8 October 2020): "So far, 346 deaths have been recorded in the register of communicable diseases and more detailed data are available ... - The median age of deaths is 84 years ... The coronavirus epidemic has not increased overall mortality in Finland, with very rare deaths among working - age people and no deaths among children and young people in Finland. (10)

Of Finland's 5.5 million population, 346 elderly people died of "corona" in about one flu season! For the most part, one or more fatal long-term illnesses! Never since 0.006% of the death of the population, even an elderly person who has passed the life expectancy, has been counted as an epidemic, let alone a pandemic. In addition, overall mortality has not increased in Finland. One might ask, then, where did those alleged victims of the epidemic go?

### 1.3 Abuses of the office continue

The Government has made several guidelines on restrictive measures, issued decrees for the introduction and application of the Emergency Preparedness Act, and decrees repealing them as follows: 17.3.2020, 19.3.2020, 20.3.2020, 25.3.2020, 27.3.2020, 31.3.2020, 6.4.2020, 15.4.2020, 6.5.2020, 12.5.2020 and 15.6.2020, etc. On 15.6.2020, the Government stated that the exceptional conditions referred to in section 3 of the Emergency Preparedness Act no longer prevail in the country and that the remaining restrictions can be lifted during the summer of 2020.

Although the illegal use of the Emergency Preparedness Act was abandoned, the "protection to death" of public health and the economy and unjustified actions continued under the disguise of a non-existent pandemic in the fall of 2020. In September 2020, talk about "strong mask recommendation" started. On 14 October 2020, the government announced (11) that the corona pandemic required reform of the Infection Act and the transfer of control to the Regional State Administrative Agency's (AVIs). The next day 15.10.2020 the Government informed about new restrictions. Apparently, the second "accelerating wave," and the people had to be protected by any means... The opening hours of restaurants and nightclubs were shortened. All these measures were taken without proper justification or knowledge of their real effects.

Based on "expert opinions" appearing in the media, a "strong mask recommendation" may become a statutory compulsion or a customer may be left without service if he or she does not use the mask. (13) Masks do not protect against viruses, it is even written in some mask packages. There is also no public health need for the use of the mask, as there is no exceptionally dangerous epidemic situation in the country. There is no justification for unconstitutional provisions and actions disguised as recommendations.

- In Finland, municipal elections to be held on 18 April 2021 have been postponed based on THL's overdue and unfulfilled forecasts, which can be considered an extreme denigration of democracy. The lowest daily infection rate forecast calculated by THL in mid-April 2021, which was used as a basis for postponing the election, proved to be about ten times too high.
- Both in Finland and at the EU level, the so-called the introduction of vaccine passports, which will lead to medical discrimination against those citizens who do not want to receive such an experimental vaccine.

#### **1.4 Beyond Incompetence**

THL's Mika Salminen even went so far in the "recommendation" of the masks that he appealed to the people: "Really, come to your senses". (14)

In reality, fabric masks have been shown to dramatically increase the number of respiratory and viral infections. (15)

Moreover, just a couple of weeks earlier, Salminen had publicly stated that "What corona looked like in the spring is not quite true" - in other words, the disease is milder than has been suggested ... "corona's overall impact needs to be reassessed." (16) In fact, this has been clear since the spring of 2020, when statistics on the epidemic and knowledge of the virus were already quite extensive. In practice, the forced mask recommendation has been unfounded from the outset and, as such, unconstitutional.

According to Article 118 of the Constitution, the government and the authorities are responsible for the proposals and decisions they make in office. In light of the evidence that came to light, THL management knew from the outset that the unconstitutional and blatantly trampling of humanity measures introduced in March 2020 and subsequently continued were unnecessary and also largely ineffective. Furthermore - it is a conventional virus that has been combated throughout human existence with common sense and enhanced hand hygiene.

As "Corona" mortality does not rise above the annual seasonal flu, there are no public health or other conditions for the new measures to control the corona, as amended by the government. In order to identify the destruction caused by the illegal corona activities of the Finnish authorities in the right context, one must know the reasons for the de facto repression in the West.

#### **2. Backgrounds to global corona terrorism**

In early 2020, the world was flooded with news of the spread of the "new" coronavirus. The media blamed horror images of a disease that quickly killed tens of millions of people. In Finland, too, hospitals would be overwhelmed by dying patients, field hospitals would be needed, and the number of ventilators would be huge. From day to day, the media repeated the number of "infections" and the number of victims. The virus would be so devastating that all of humanity would be in danger if societies were not closed, the elderly isolated and healthy people forced to stay in their homes. In a society that is instantly classified as sick, people would be so dangerous to each other that only masks with their faces, meters apart, would move outside. Medical resources would be targeted at fighting the killer virus rather than other treatments until a vaccine is available. For the first time in human history, healthy, asymptomatic citizens began to be subjected to a wide range of regulations and measures restricting personal liberty, instead of targeting infected and protected groups at risk, in line with old practice.

Only a vaccine would save human lives, the world economy, and humanity. This horror fantasy created by the sick mind (evidence below) exists only in the media and in the speeches of the authorities.

## **2.1 Hysteria is maintained in unsuitable pandemic models**

The horror fantasy was set in motion by Neil Ferguson, a former professor at Imperial College, whose unworthy computer modeling predicted the deaths of half a million people in Britain alone. The modeling was so wrong that *The Telegraph* called it "the most destructive bug of all time." (17) As Director of the Vaccine Impact Modeling Consortium (VIMC) at Imperial College, Ferguson was an adviser to both the United Kingdom and the WHO in the fight against the corona pandemic. (18) On 5 May 2020, Mr Ferguson resigned after being caught in breach of the quarantine regulations (Lockdown) which he had himself recommended as an expert. (19)

Imperial College and VIMC receive significant support from the Bill & Melinda Gates Foundation, the vaccine lobbying group GAVI, founded by Bill Gates, and the Wellcome Trust. In the service of vaccine lobbyists, Ferguson has a long history of making socially destructive "predictions" since foot-and-mouth disease. In 2005, Ferguson "predicted" that bird flu H5N1 would claim the lives of 200 million people. In 2006, the WHO confirmed that only 78 people had died of H5N1 worldwide. (20)

## **2.2 "From forecasts" to criminal liability**

Nor could Ferguson's model of corona mortality realistically predict anything. And that was obviously not the intention. In contrast, the model acts as a sower of general fear, serving those with huge financial interests in a corona pandemic and against whom several criminal cases are pending or coming.

In Belgium, Ferguson is already a defendant in civil and criminal lawsuits, along with Bill Gates and the Belgian health authorities. Ferguson is being held accountable both for falsifying corona mortality predictions and as a former advisor to the WHO, Gates as the WHO's main sponsor, public marketer of social exclusion, masking and large-scale testing, and an investor (not a donor!) Another lawsuit is filed by the Viruswaan group of a couple hundred entrepreneurs. Its Dutch name, "infectious madness," tells us what Belgium (and the wider West) think about terrorizing citizens under the disguise of corona. (21)

It is noteworthy that shortly before the commencement of criminal charges in Belgium, the WHO withdrew from Ferguson's advice, condemning the closure of societies as "unnecessary destruction" that has doubled poverty in a short time. (22) The current lockdown policy is therefore not based on WHO guidelines but is currently being implemented in clear contravention of the WHO's position.

### **2.3 Fake investigations, paid false news in media and so called "experts"**

On March 19, 2020, the European Journal of Clinical Investigation published a study by John P. A. Ioannidis, Doctor of Immunology and Statistics at Stanford University, Coronavirus disease 2019: The Harms of exaggerated information and non-evidence-based measures. It states: "It is important to distinguish the real pandemic from the false claims and the harmful actions that justify them." According to Ioannidis, the corona situation comparable to seasonal flu was inflated into a "pandemic" from the beginning, using a few studies withdrawn from medical publications as invalid, in which predictions of infection and death had been inflated. In Ioannidis's words, "leaders emphasize that the corona is a once-in-a-century pandemic that can be used to justify anything: lockdowns, mental and financial damage, the allocation of health care resources to treat a non-existent pandemic - "This shows how non-factual science can do enormous damage." (23)

The perpetrators of the dishonest investigations mentioned by Ioannidis have financial ties to individuals with huge revenue expectations from the corona pandemic and against whom criminal charges are pending and coming.

John Ioannidis has published in the WHO Bulletin on 14 October 2020 an extensive analysis of the Infection fatality rate of COVID-19 inferred from seroprevalence data for the period 2019-2020 in which the corona epidemic is located, stating that the corona epidemic was mainly seasonal influenza. Post analysis of the matter therefore does not support ongoing corona distractions. (24)

### **2.4 Finnish fake news**

Finland is not immune to the false news mentioned by Ioannidis, which has been coordinated from around the world. (26) Perhaps the most egregious category of "news" includes "brave caretakers at the forefront of the coronation battle." In Finland, firefighters were even added to these "heroes": according to the April 2020 Seura magazine, the corona situation in Finland was so bad that alongside the nurses, firefighters were fleeing the horror virus - which, according to statistics, has never been true, let alone medically justified. (27) In almost a year, the 346 elderly people who died of corona, the vast majority of whom had one or more long-term illnesses at the time of death, hardly give 5.5 million populations in Finland reason to speak of a "crown", let alone being at the forefront.

### **3. How to create a "Pandemic" that do not exist?**

On the same day (March 19, 2020), when the Ioannidis study was published, Finnish TV Channel, MTV reported that based on Ferguson's modeling, it was predicted that up to 40,000 people in Finland were expected to die from corona. THL's chief physician Tuija Leino doubted such a figure. Leino assured that corona is fairly harmless for the most part and predicted that the epidemic peak will take place in Finland in the second week of May. (28) As the Ioannidis study and the Facts About Covid-19 database show, a wide range of experts in the field already knew at the time that there was no "dangerous pandemic". And the same WHO had only informed a couple of weeks earlier. The Ferguson model, and the false investigations and false news revealed by Ioannidis, suggest systematic and international cooperation to violate civil liberties and rights at the constitutional level. (29)

#### **3.1 Falsification of death statistics**

Ongoing intentional activity includes both the brazen falsification of the number of corona deaths, in which thousands of deaths from other causes are marked at the peak of the corona, and the more veiled manipulation of statistical data. The former is openly pursued, (30) the latter is based on innocent changes in the documentation and statistics of causes of death that came into effect during the pandemic. In early April 2020, the U.S. Communicable Diseases Agency (CDC) issued new guidelines for drawing up death certificates. (31) According to them, a person has died in a corona if the person who issued the death certificate assumed a corona as the cause of death. This was despite the fact that the

deceased had not been tested for a corona or had one or more fatal illnesses at the time of his death. According to many experts, the new practice "is Irresponsible and artificially raises the number of corona deaths". It is also suspected that the corona death rates artificially raised in this way will allow hospitals and other health care facilities to milk more federal money earmarked for corona operations from the Federal Government. Minnesota State Senator, Republican Jim Abeler, known as a major health legislator, said:

"A death certificate cannot be a "maybe " document. There should be no room for assumptions. From the moment we put a perhaps presumption on the death certificate, we have a worthless document based on opinion" (32).

There is also a third way to falsify "corona" mortality statistics. One of President Trump's advisers in the early days of the pandemic, Deborah Birx of the Bill & Melinda Gates Foundation, told a White House press conference that those who died positive on corona tests . According to Birx, "it is convenient that the death certificate has a check box ready." (33)

The background of the Italian "corona death spike" in the media has also revealed a huge political scam: 99.2% of those who died had one or more serious illnesses, and the real cause of death was quite different from corona. (34) In April 2020, Vittorio Sgarbi, a long-time Italian Member of Parliament, gave a fiery speech in Parliament in which he outraged his colleague who had spread false death statistics in public:

"24,075 did not die at the crown, it's a lie! Professor Bassetti said they died of a heart attack, cancer and others ... Let's join forces against lies and counterfeiting! Let's not let these false statistics terrorize Italians. Let's not let them humiliate Italy. Let's not humiliate Italy. false news! " (35)

### 3.2 Pandemic of testing

In light of the above, it is not surprising that the international medical-law team calls the corona pandemic the greatest scam and crime against humanity in history - so much social destruction has been brought about by falsifying statistics. But a corona pandemic is maintained by another criminal procedure called a testing pandemic by a team of experts. This is a large-scale use of PCR tests that give false positive results *en masse* and are completely unsuitable: positive corona results have even been obtained from goats and papaya fruits. (36) According to experts, the aim is to produce as many false positives as possible, which create the illusion of the existence of a large, dangerous pandemic.

When the falsification of the number of deaths and the falsification of infections are put together, we have a horrific scale of scam - and a crime of terrible scale under both national and international law. Fortunately, most people involved in this cross-border organized crime are known.

### 3.3 Disqualified tests

In a videotaped press conference on the multinational lawsuit, Dr. Fuellmich quoted Dr. Mike Yeadon, former research director of the Pfizer drug giant, Lies, Damned Lies and Health Statistics - the Deadly Danger of False Positives, which says:

"The probability that a seemingly positive test result is false is between 89% and 94%, or close to certainty." (37)

### **3.4 Experimental vaccine**

The experimental vaccine, which has only received an emergency permit and is based on a completely new vaccine technology, is an illegal human experiment in living people, even in fragile elderly people. Use of experimental vaccine on the entire adult population is also cruel and unjustified. (38)

The Finnish adverse reaction register is incomplete and presents only a few harms. Vaccines are subject to conditional emergency approval by the U.S. Food and Drug Administration (FDA) (39). They have not been approved by the FDA and there are no peer reviews. Their clinical trials are ongoing. Long-term effects have not been studied, some vaccines have not been tested on animals, some vaccines have not been tested on the elderly and the debilitated. This so-called mRNA experimental vaccine is not even a vaccine in the medical sense. It is a form of genetic engineering treatment whose research has so far been very deficient. This so-called the vaccine requires further investigation. It is also important to find out what it is in legal terms before it can be used ethically and without violating laws and regulations. Staff who vaccinate people with an experimental vaccine are not trained as required by the situation. The staff does not understand the medical and legal dimensions of the measure. Experimental vaccination requires peoples written consent and knowledge of ethics. The potential deaths and harm caused by the vaccine are not thoroughly investigated but are stated to be due to the vaccine. This is against the practice of scientific research.

AFLDS has studied the safety of the vaccines and says the following about COVID-19: Vaccine safety requires appropriate animal testing and peer reviews, neither of which has taken place. This also applies to previous failed coronavirus vaccine studies that resulted in the death of experimental animals. They examined SARS-CoV-1 virus, which is 78% identical to SARS-CoV-2 (COVID-19). Previous coronavirus vaccines, like other respiratory vaccines, have failed due to pathogenic overexpression of the immune system (the so-called ADE reaction). Overexposure makes a vaccine susceptible to a sudden fatal illness caused by a massive cytokine storm when the vaccine is exposed to a natural virus. In addition to pathogenic overexposure, there are three other potential safety issues that are often overlooked. While we hope the vaccine is both effective and safe, hope is not science. Because these experimental vaccines have not been tested to standard standards, their safety is a matter of serious concern to us. (40)

Chief physician of the Department of Health and Welfare (THL), Hanna Nohynek, has been guilty of gross misleading citizens by providing citizens with incomplete and misleading information about vaccinations, the safety of which they have not been able to be sure of and whose experimental nature has not been proven to have been communicated to them before vaccination. The FDA and EMA required and require, at the time of vaccine administration, that the vaccinee be fully aware that he or she is participating in experimental testing of a vaccine that is still in development and whose health effects are nowhere near that previously available for human vaccines. THL has not agreed to answer why it does not use the word "experimental" in its own communications.

Finland and Finns have a special position. Finland has an exceptionally strong culture of trust between Finnish citizens and authorities. This means that Finns have trusted in the honesty and reliability of their own officials as much as possible. This has also been known to officials. Therefore, exploiting the trust of the Finnish people in the way that has now happened is particularly aggravating.

Hanna Nohynek, Chief Physician of THL, who is the chair of the international expert group to strengthen the organization of Covid-19 vaccinations, established under the auspices of the WHO sub-organization SAGE in spring 2020, is primarily responsible. Already in the spring of 2020, he has stuffed Finland and Finns as the first guinea pigs for these completely unfinished and unpredictable vaccinations. She stated in the Finnish Magazine Ilta Sanomat: "Finland is well suited for corona vaccine testing". (41)

A large number of people have been vaccinated in Finland, some of whom have already died, some of whom have had serious side effects and a large number of milder ones, and whose health condition will be fraught with risks in the future. Citizens have blindly believed, based on the Finnish culture of trust, in the communication of officials and especially THL and Hanna Nohynek. Mislead citizen have taken the vaccinations, relying on Nohynek's risk-reducing message and Nohynek's disease-enhancing message, and that Nohynek has explained that the vaccine provides a health benefit to the vaccinee.

In addition, THL has not mentioned on its own pages about the drugs that could have taken in the early stages of covid-19 infection that exist and are available. Doctors have not been using these medicines and the general public is not aware about the option at all. Ivermectin (42) and hydroxychloroquine (43) have shown to be good medicine that shorten the sickness time and help the patient in many ways. As a result, people have been given false and propaganda biased information by the highest Health Authority in the country. Enormous human suffering, death, isolation, suicides, vaccine caused sickness and handicap have taken place and continues to take place in Finland.

Doctors for Covid Ethics is a group of over 100 doctors and scientists from 25 countries. Doctors and scientists from 25 countries have issued a letter on March 1<sup>st</sup>, 2021 to the European Medicines Agency (EMA) with warnings regarding COVID-19 vaccine dangers from clotting and bleeding. ( 44)

Within days of the EMA receiving the group's original letter on March 1st, outlining risks of blood disorders from COVID-19 vaccines, over a dozen countries suspended the AstraZeneca vaccine following deaths from clotting and bleeding, as the doctors had warned.

On March 23rd, however, the EMA dismissed the group's concerns as relating to "minor" and "rare" events, concluding that "a positive benefit-risk balance has been established."

Doctors for Covid Ethics have issued a rebuttal letter to the European Medicines Agency (EMA). (45)

The doctors and scientists are accusing the EMA of misleading the public on the vaccines' true risk-benefit profile. "Your reply of March 23 is unconvincing and unacceptable," they wrote, noting that recorded cases of life-threatening cerebral venous thrombosis (CSVT) post-vaccination likely "represent just the tip of a huge iceberg". Common reactions to vaccination, including headache, nausea, blurred vision and vomiting, they state, are symptoms of CSVT, and should be assessed as such, immediately. Clotting and bleeding after vaccination can also "be expected to increase with each re-vaccination, and each intervening coronavirus exposure" the group warned. Over time "this renders both repeated vaccination and common coronaviruses dangerous to young and healthy age groups, for whom - in the absence of 'vaccination' - COVID-19 poses no substantive risk.

"Such is the real risk-benefit analysis of the COVID-19 'vaccines'. Either the EMA lacks the subject-matter expertise to appreciate the molecular science of this reality, or it lacks the medical ethics to act accordingly", say Doctors for Covid Ethics.

Doctors for Covid Ethics, which includes professors of immunology and microbiology, described the EMA's responses to their concerns as "unscientific", "vague", and lacking credibility. The experts have offered to liaise with the agency to mitigate against vaccination risks and ethics violations, including helping the EMA to "craft a focused pharmacovigilance plan."

The group warned that continuing to administer inadequately tested gene-based COVID-19 vaccines represents dangerous medical experimentation, whose "true risks far outweigh any theoretical benefits", reflecting "serious violations of medical ethics and citizens' medical rights."

“Misleading populations into accepting investigational agents such as the gene-based COVID-19 ‘vaccines’, or coercing them through ‘vaccine passports’, constitutes clear and egregious violations of the Nuremberg Code”, they caution.

The letter is addressed to Emer Cooke, Executive Director of the EMA, and was copied to the lawyer Reiner Fuellmich, Charles Michel, President of the Council of Europe, and Ursula von der Leyen, President of the European Commission.
